**TYPICAL SYSTEM DATA****PROCESSING**

Mix ratio	Parts by weight
RenGel <sup>®</sup> SV 410	100
Ren <sup>®</sup> HY 2404	14

Mix the two components thoroughly in the ratio indicated.  
Apply in thin layers with a brush or spatula, wait until gelcoat has gelled, but ensure that it is still slightly tacky before proceeding.  
Post-curing will improve final properties.
